



## **Strong case to revisit FDI retail policy: Report**

DOMESTIC RATINGS agency Icra has said there is a “compelling case” to revisit the “restrictive” retail foreign direct investment (FDI) policy as India has not been able to get sizeable investments despite opportunities. Citing examples of other emerging geographies to allay concerns, the agency said organised and unorganised retail can co-exist.
